PROSPECTUS FOR ADMISSION INTO M.D.(HOMEO) COURSES - 2024-25.

1. The following are the Regulations for admission into M.D. (Homoeo) courses under Competent Authority Quota in affiliated Homoeo colleges for the academic year 2024-25.

2. NUMBER OF SEATS:

The number of seats (Seat Matrix) for admission into each of first year M.D. (Homoeo) courses for the academic year 2024-25 will be notified on KNRUHS website before counseling. If any new courses / colleges are permitted, those seats are also shall be filled-up and no further notifications will be issued.

15% of seats in each subject of MD Degree in J.S.P.S. Govt. Homoeo Medical College, Hyderabad are allocated to All India Quota to be allotted by Government of India (AACCC) Counseling Authority. Remaining 85% seats will filled by State Competent Authority i.e., KNR University of Health Sciences, Telangana State as per the rules and regulations of Government of Telangana.

15% of the seats in Private Homoeo Medical Colleges shall be notified as All India Quota seats and separate counseling shall be conducted by KNRUHS. 35% of seats shall be added to Government College seats to be filled up as Competent Authority Quota.

3. ELIGIBILITY FOR ADMISSION:

Candidate should have appeared and qualified in AIAPGET 2024

- 3.1 Those who have passed the BHMS Degree Examination after undergoing a course of study in Homoeopathy of not less than 5 ½ years duration including the period of compulsory internship; or Those who passed equivalent Degree Examination included in the 2nd schedule of Homoeopathy Central Council Act 1973 from Homeo colleges in the State of Telangana.
- 3.2 The candidates should have completed internship by 31.08.2024 and they shall submit a Certificate to that effect.
- 3.3 Candidates who have appeared AIAPGET 2024 and whose names are included in the merit list of AIAPGET-2024 for Homeo P.G. are only eligible to apply, subject to fulfillment of regulations, Candidate should secure the following minimum eligibility percentile or above.

- a) 50th Percentile for General Category (Open) candidates.
- b) 45th Percentile for General Category (Persons with Disabilities (OC-PWD)) candidates
- c) 40th Percentile for SC, ST and other Backward class including Persons with Disabilities

Candidates who are already admitted and studying M.D. (Homeo) course shall not be permitted for counseling, until they discontinue the course before submitting the application form and such candidate shall submit the discontinuation certificate issued by the Head of the Institution along with the application.

3.4 ELIGIBILITY AS LOCAL CANDIDATES:

(as per G.O. Ms. No. 148 HM&FW(C1) Dept., dated 28-10-2024)

- i. A Candidate to be eligible for Admission into PG AYUSH Courses under these Rules should be an Indian National/Person of Indian Origin/Overseas Citizen of India card holder and be a local candidate:
- ii. Local candidate means a candidate who has studied in the Educational Institutions in the state of Telangana as for a period of not less than four consecutive years ending with the academic year in which he appeared or as the case may be, first appeared in the relevant qualifying examination subject to

Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (UG AYUSH) in the state of Telangana, but has studied in a State wide Institutions outside the state of Telangana, shall also be regarded as a Local candidate.

Explanation (b): A candidate, who has secured Admission to the relevant Undergraduate course (UG AYUSH) under Non-Local Quota in the State of Telangana, shall not be regarded as Local candidate.

3.5 Candidates who are already holding a Post Graduate Degree in Homoeopathy in a subject shall not be eligible for admission into another P.G. Homoeo Course.

3.6 For in-service candidates three years of regular service shall be calculated as on **30-09-2024**. The in-service seats are available subject to the rules and regulations of Government of Telangana. The admissions into in-service seats will be considered subject to deputation orders issued by Government of Telangana.

3.7 Regarding seats of Central Government Nomination (CGN), Revised Guidelines shall be applicable communicated by Govt. of India vide Letter F.No.R.12013/02/2014-E&C(PG) dt.17-07-2014 .

4. RESERVATION:

4.1 15%, 10% and 29% of the seats available in each course shall be reserved for SC, ST and BC categories respectively under Competent Authority Quota.

4.2 A candidate claiming reservation under clause 4.1 shall produce latest certificate of his / her social status in the prescribed standard format.

4.3 The seats reserved for the SCs shall be made available to the STs and vice-versa, if qualified candidates are not available in these categories. The seats reserved for both SCs and STs shall be made available to the candidates in general pool, if qualified candidates belonging to the SCs and STs are not available.

4.4 15% of seats in PG courses are reserved for in -service candidates in each category. Candidates selected on merit in the respective categories shall be counted against in- service quota. Candidates working on contract basis, consolidated pay basis, daily honorarium and ad hoc basis are not considered as regular service candidates.

4.5 Candidates from the Scheduled Castes, Scheduled Tribes and Backward Classes belonging to castes which are notified in the list as per the Telangana Government orders will be considered against the respective reserved seats.

Explanation: An in-service candidate is one who has put in a minimum of three years of regular Service certified by Director of AYUSH Govt. of Telangana.

4.6 **Reservation for Persons With Disabilities (PWD) :**

5% of seats in each specialty course wise are reserved for Persons with Disabilities category candidates. (PWD Quota reservation will be followed if sufficient number of seats are available for each course under each category).

4.7 **EWS reservation:**

Will be implemented as per the seats sanctioned by Government.

4.8 The number of seats reserved to various categories are as per G.O.Ms.No.603, HM & FW (R2) Dept., dt. 28-12-2004 and after making provision for 1 seat in Homoeopathic Philosophy & Organon for foreign nationals as per Government of India Letter No. R 12013/1/2003- E&C (ii) dt 23-3-2004

4.9 If no candidate is allotted by Government of India for One (1) seat in Organon Philosophy, the seat will be allotted as per the Merit as per the G.O.Ms.No.88, HM&FW (R2) Department, dated. 21-03-2005.

5.2 The candidate should fill the online application form available in the Website with the data required-for, through internet. The online application form can be filled through any computer with internet connection with internet explorer 11 version (home/internet café/net center). The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates, Scanned Photo and Signature in the .jpg/.gif format separately (as shown below) (step-1) and ready to enter his/her correct data and upload the photo and signature after the payment of application fee through Online.

- 5.6 The candidate should sign at the declaration area in the print out of the online application form and also put left hand thumb impression at the space provided without fail.

6. Registration and Processing Fee:

The registration and Processing fee is Rs. 4,000/- (Bank transaction charges extra) for OC/BC categories and Rs.3,000/- (Bank transaction charges extra) for SC/ST categories. For GOI Nominees - Rs.4000 + Bank charges

7. VERIFICATION OF ORIGINAL CERTIFICATES:

University will notify the schedule for counseling after verification of uploaded original Certificates of the candidates and preparation of final merit list for exercising options by the candidates.

8. MERIT LIST :

Merit position of candidates shall be determined based on percentile and rank obtained in AIAPGET-2024.

9. TUITION FEES:

- 9.1 All the selected candidates are required to pay the admission fee, college fee, tuition fees etc., as per rules in force.
- 9.2 **TUITION FEE:** All the candidates selected are required to pay the tuition fee as notified by the Government. If any of the candidates who have joined in a course is allotted to another course in the subsequent phase of counseling, the tuition fee paid by the candidate will be adjusted to the newly selected course and the tuition fee paid already shall not be refunded under any circumstances.

10. UNIVERSITY FEE:

Allotted candidates have to pay the following University fee through payment gateway for downloading the allotment order. The fee once paid shall not be refunded under any circumstances.

UNIVERSITY FEE : 15,000/- (Rupees Fifteen Thousands only)

11. SELECTIONS:

- 11.1** Provisional Selection shall be made by the Selection Committee constituted by the University.
- 11.2** The Selection Committee shall provisionally select the candidates as per these regulations from among the candidates who qualified **AIAPGET** 2024 as per merit list.
- 11.3** The candidates shall upload their original certificates for verification and after verification merit list shall be notified. Eligible candidates notified in the merit list shall exercise web options for the courses they are interested to join in order of priority as per the schedule notified by University.
- 11.4** The candidates shall exercise their web options for subjects in order of their priority. The Selection Committee will select the candidates as per the Admissions Regulations and Government Rules from among the candidates who have completed the verification of original certificates, are eligible, have been notified in the merit list and exercised their web options. The list of provisionally selected candidates will be displayed and the provisional selection intimations will be issued to the selected candidates.
- 11.5** The Selection Committee shall have power to review the provisional selection in case of any errors, misrepresentation, fraud or glaring injustice. In all matters relating to selections and admissions, the decision of the selection committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.
- 11.6** If a candidate after choosing the subject fails to pay fees or fails to submit the bond, his/her selection stands cancelled automatically. If a candidate does not exercise web options in the first phase, he/she will not be considered for selection at the subsequent selection in the then available courses
- 11.7** If a candidate after allotment to the PG AYUSH specialty course fails to pay the fees or after paying the fees fails to submit the bond, original certificates, the selection of such candidate shall stand cancelled automatically and the candidate will not be eligible for selection for the next phases of counseling.

Vacancies after the 1st/2nd phase of counseling shall be filled by another phase of web-based counseling as per the schedule notified by the University on the website of the University.

12. CONDITIONS OF ADMISSION:

- 12.1** The Principal of the allotted Homeo Medical College shall verify the correctness of documents. On his satisfaction he shall direct the candidates to credit the college fee etc., immediately. In case of any discrepancy, the allotment shall be cancelled and necessary action shall be initiated by the University.
- 12.2** Candidates joining courses shall execute a bond on non judicial stamp paper of value of Rs.100/- in the form specified in Annexure-I to ensure completion of the prescribed period of training or in default or for any other reason has to pay Rs.1,00,000/- to the Registrar, KNR University of Health Sciences and shall refund the stipend received upto that date to Government.
- 12.3** The Original certificates submitted shall not be returned to the candidates till they complete their course.
- 12.4** Candidates selected to various courses shall be whole time students. Service candidates will have to apply for study leave and are required to produce the orders wherein such leave has been sanctioned to them from the Competent Authority within 3 months after joining the course

13. ATTENDANCE AND LEAVE:

- 13.1** The post graduate students shall mandatorily complete eighty five percent of attendance in all subjects separately for eligibility to appear for the final examination.
- 13.2 Leave:** The Post Graduates are eligible for 30 days leave in the academic year and they can avail a maximum 10 days at a time. If they avail more than 10 days at a time, the stipend shall be deducted proportionately. The balance of leave in any year shall not be carried forward to the next academic year.
- 13.3 Maternity leave:** Post Graduate students are eligible for maternity leave as per Government rules and the period of study shall be extended accordingly.

14. SANCTION OF LEAVE BEYOND 3 MONTHS AND TERMINATION OF STUDENTSHIP

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of 91 days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b. If the break of study (91 days are more) in more than one spell, the candidate's representation in the prescribed proforma shall be forwarded to Government for appropriate decision in the matter with the specific recommendations of the Executive Council of the University.
- c. Candidates who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission in to the course and the studentship stands cancel without any further notice.
- d. The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Commission for Homeopathy from time to time.
- e. e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course

15. PRIVATE PRACTICE:

PG students are not permitted to do any private practice or consultation practice and shall not accept any part-time employment during his/her Post Graduation.

16. COLLEGE REGULATIONS:

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University and they shall not make any correspondence with higher authorities directly without prior permission of the Professor of the concerned unit and Principal.

17. STIPENDS:

17.1 Stipends may be paid by the Principal as per the orders of Government of Telangana to the PG students who are regular in attendance and show good progress every month in their academic pursuits. The total period during which the stipends may be paid to the students shall not exceed thirty six months for the course. No candidate will be eligible to draw the stipend for more than 36 months during the entire PG study period.

17.2 Service candidates shall not be paid stipend if they draw leave salary or salary.

18. COMMENCEMENT OF THE COURSE:

The course shall normally commence as per the date mentioned in the schedule at last page. The duration of the course shall be calculated from this date of commencement of the course and shall be uniform for all the candidates irrespective of their individual dates of admission.

19. CLOSURE OF ADMISSIONS:

19.1 Admissions shall be closed as per the schedule notified by NCH.

19.2 Any vacancy as on the day of closure of admissions or that arises after closure of admissions shall not be filled up.

20. DURATION OF COURSE AND MAXIMUM PERIOD FOR COMPLETION OF THE COURSE:

The period of training of Doctor of Medicine in Homeopathy shall be of 3 years duration in the department concerned. Candidate should complete the course within the duration equivalent to double the period of course of study .i.e.,: 6 years

21. MEDIUM OF INSTRUCTION:

English shall be the medium of instruction and examination

22. POWERS OF THE PRINCIPAL:

Notwithstanding anything contained in these regulations, the Principal of the College may at any time before completion of the PG course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and or a personal hearing, order the cancellation of admission to the PG course if in his opinion such candidates had furnished false or incorrect information in

the application form or in the documents attached, certificates enclosed there to or in the statements made either before the authority in charge of admissions or the Principal or in any other fraudulent manner, obtained admission into such course. Against any such order of the Principal an appeal shall lie to the KNR University of Health Sciences, Telangana, Warangal.

23. POWER TO AMEND REGULATIONS AND REVIEW SELECTION OR ADMISSION OF CANDIDATES:

23.1 The KNR University of Health Sciences shall have the power to add or to delete or amend or alter these regulations from time to time.

23.2 The University may either suo moto or on an application made to them, call for and examine records relating to any selection or admission or cancellation thereof made by the authority in charge of selection or admission for the purpose of satisfying themselves as to the legality or regularity of such selection or admission orders in relation thereto, as they deem fit including cancellation of the selections already published or admissions already made provided that the University may before cancelling such selection or admission give an opportunity to the authority in charge of selection or admission and to the person effected to show cause against such cancellation.

24. FINALITY OF SELECTION:

All selections under these Regulations shall be subject to any general regulations or order that may be made by University from time to time.

25. MIGRATION /TRANSFER:

No Transfers during the course period are permitted from one college to another college and from one course to other after closure of admissions under any circumstances.
